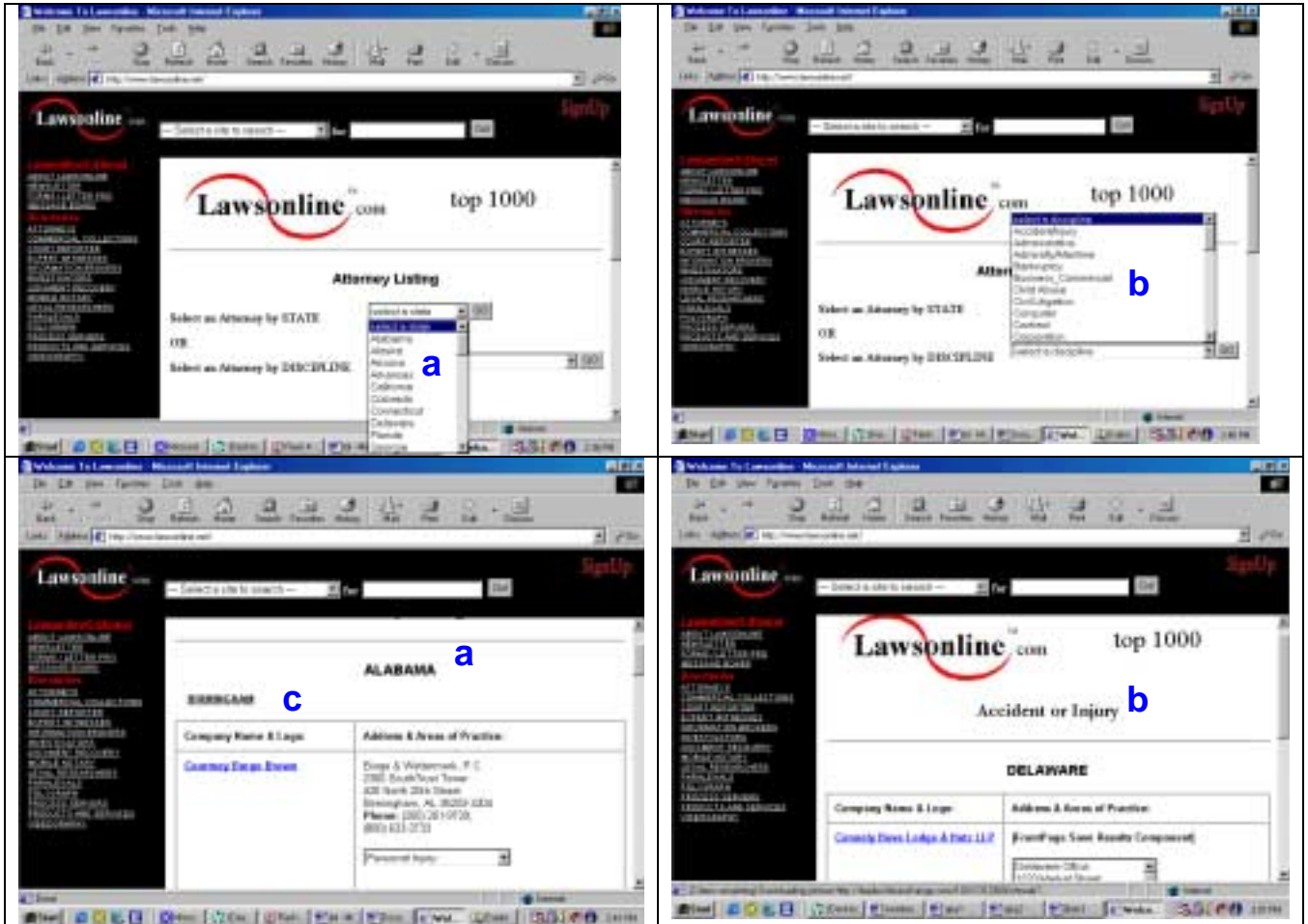


## Top 10 Questions & Answers for Lawsonline.com

1.) How does lawsonline membership listing work? Each individual, attorney or firm is listed by:

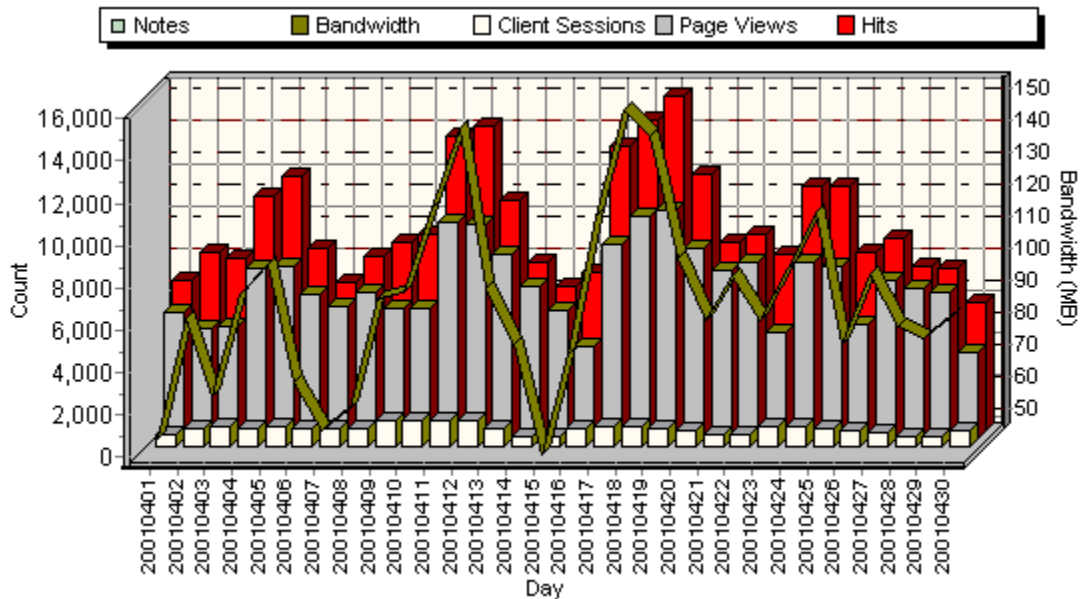
- a. State where they practice

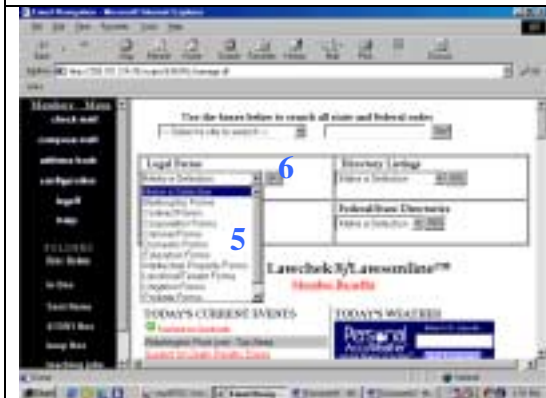
- 4.) Forms: we are one of the only sites that has over 10,000 Legal Forms and Questions that are state specific. This is only one of the large benefits of being a member.

  - d. Other forms – sites are not state specific and many of those have a grab bag of generic forms



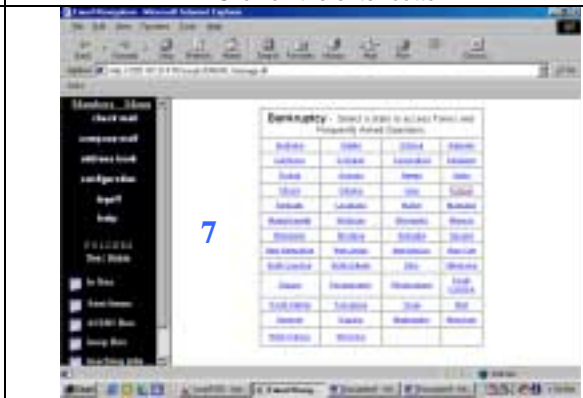
1. Click on "members enter here"



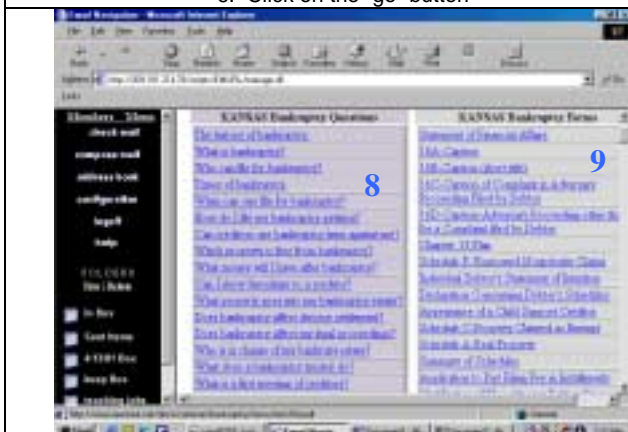
2. Type your login name here

4. Click on the enter button



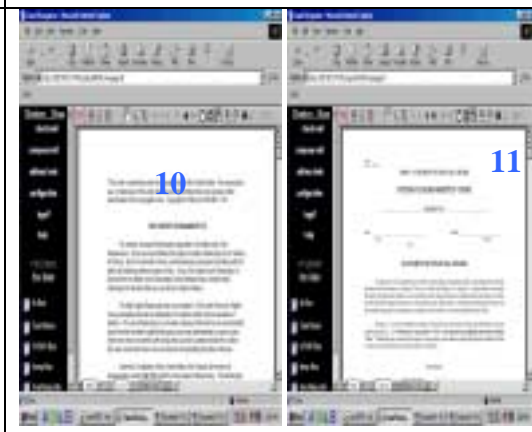
5. Click on legal forms and pick a category

7. Select a state and click



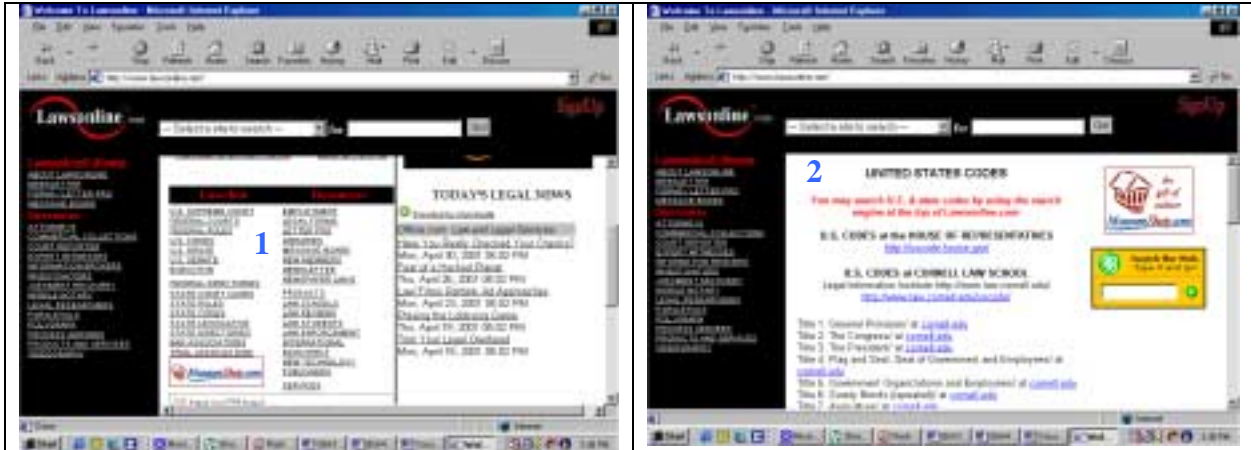
8. On the left is a column of questions regarding the category you choose. Click on one for an explanation.
9. On the right is a column of actual forms regarding the category you choose. Click on one for the legal form.



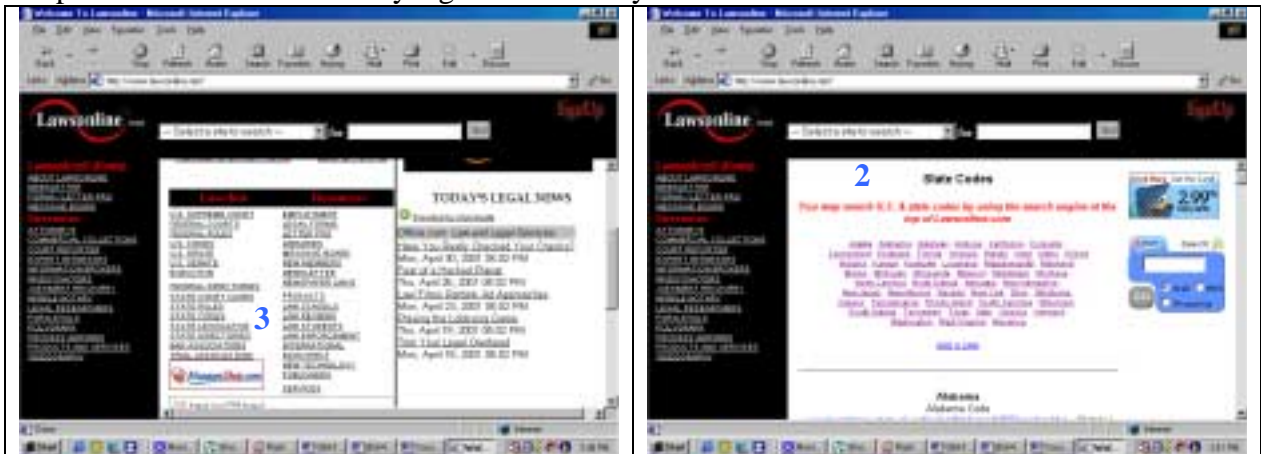
10. This is the explanation of the question you wanted to look up.

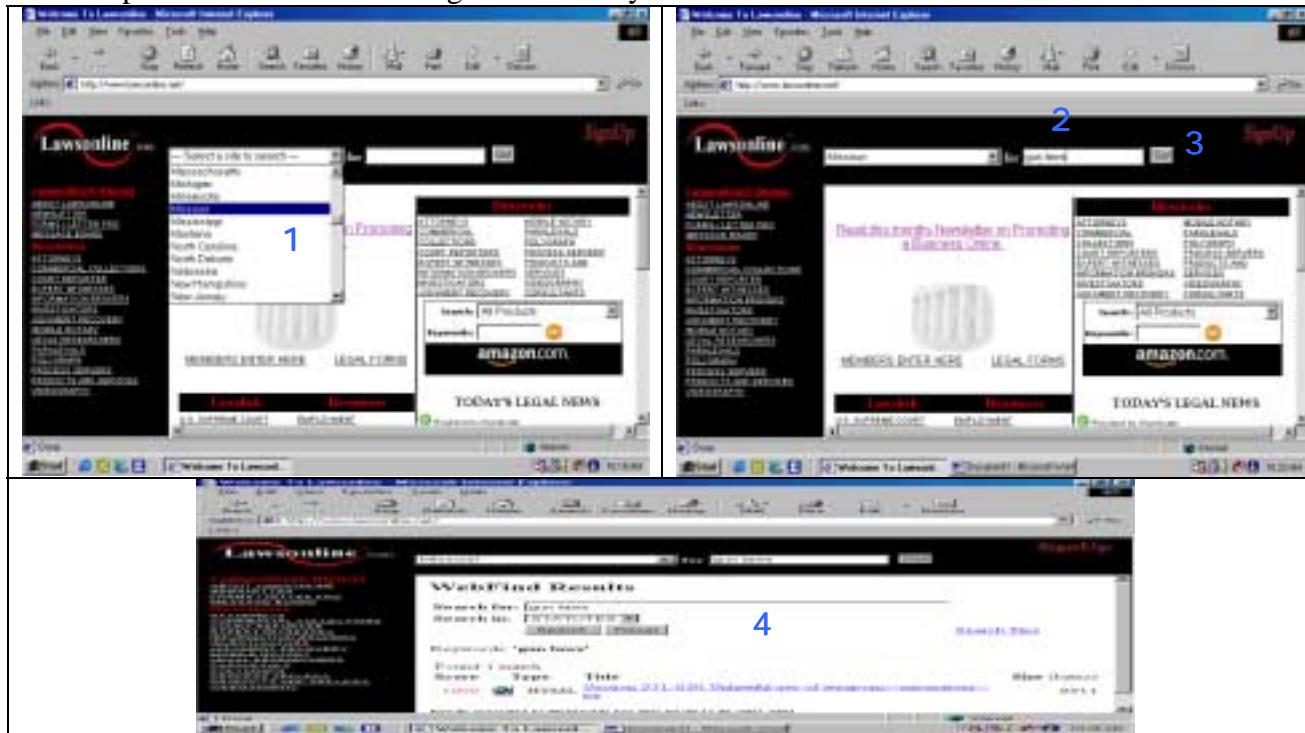
